ALL OWNERS, TRAINERS, RIDERS MUST BE MEMBERS OF WDAA OR PAY A NON MEMBER FEE OF \$55.00 for adults or \$40.00 for juniors

CHANGES TO THE USEF SHOW PASS

- 1. NON-MEMBER PARTICIPANTS IN THE ROLE OF RIDERS, DRIVERS, HANDLERS, VAULTERS, LUNGERS, OWNERS, LEASSEES, AND AGENTS MUST PAY A SHOW PASS FEE. SHOWS PASS PURCHASES CAN ONLY BE MADE ONLINE.**
- 2. NON-MEMBER PARTICIPANTS IN THE ABOVE ROLES ARE LIMITED TO OBTAINING NO MORE THAN 1 SHOW PASS PER COMPETITION YEAR**
- 3. TO BE ELIGIBLE TO PARTICIPATE AT A USEF COMPETITION, ALL PERSONS ACTING AS COACHES OR TRAINERS, AND LEGAL GUARDIANS SIGNING ENTRY BLANKS AS COACHES OR TRAINERS ON BEHALF OF THEIR MINORS MUST BE SENIOR ACTIVE MEMBERS IN GOOD STANDING**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining Competitions and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass Fee. Participates in the following are exempted from the requirement of this rule: 1) leadline, 2) exhibitions, 3) games and races, 4) classes for 4H members, 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program, 6) USDF introductory level tests, pas de deux and quadrille classes, 7) assistant handlers in Dressage Sport Horse Breeding classes
